

## Financial Obligation Agreement Faculty Led Programs

I understand that enrolling in a study abroad program at the University of North Texas (UNT) commits me to specific financial obligations and responsibilities including but not limited to the following categories. As a student applying to participate in a UNT study abroad program (the Program):

- I understand that I must pay **\$100 Application Fee** through my online application at <u>studyabroad.unt.edu</u> before I will be considered an applicant to the Program.
- I understand that after being accepted to participate in the Program, I must pay a **\$500 Program Confirmation Deposit** through my online application at <u>studyabroad.unt.edu</u> by the specified deadline in order to confirm my participation.
- I understand that upon confirming my participation in the Program, SAO will charge a **Program Fee** to my UNT student account. I am expected to pay the posted Program Fee by the posted due date.
- I understand I will be registered for the minimum number of credits required by the Program and will be charged based on my student status and tuition plan. I will also be charged standard UNT registration fees when enrolling in the Program course(s), including, but not limited to, the Student Service Fee, Technology Use Fee, Library Use Fee, Undergraduate Advising Fee, International Education Fee, and Publication Fee. I may visit the <u>UNT Tuition and Fees Schedule</u> for a description of UNT tuition and registration fees, and special class fees.
- I understand that I am expected to pay all **UNT tuition and fees** associated with the Program as normal, by the posted due date(s) through my UNT student account.
- I understand that **additional expenses** including, but not limited to, round-trip airfare, personal spending, course books and materials, meals not covered by the Program, passport, supplemental insurance, and incidentals are my sole responsibility and are not part of the Program fee charged to my UNT student account.

## I further understand that:

- If the Program is cancelled while I am an active Program applicant, I will receive a full refund of the SAO fees I have already paid. In order to remain an active applicant, I must complete all required tasks by the Program deadlines. The Study Abroad Office will endeavor to refund payments made through my online application or remove any fees charged to my UNT student account within 15 business days of Program cancellation. I understand and agree that SAO will not be responsible for, and I will not be entitled to compensation for, any personal expenses or losses incurred as a result of Program cancellation, including, but not limited to, airfare, passport and visa fees.
- If I am a Financial Aid or Scholarship recipient, I acknowledge that it is my sole responsibility to make arrangements for these funds to apply to the SAO fees outlined above. I understand that because of deadlines associated with contractual obligations for the Program, there is a strong possibility that I may not know how much Financial Aid or Scholarship funding will be available to me for the term of the Program until after some or all Program payment deadlines.
- I am obligated to make full payment for all registered classes and/or schedule changes in accordance with the <u>UNT tuition payment schedule</u>. There is no installment payment option for the summer semester.

- My tuition rate may be affected by changes in my enrollment, including excessive hours charges. I am responsible for paying additional charges by the payment deadline.
- I agree to pay any additional amounts incurred by UNT on my behalf due to my actions or decisions.
- I understand that failure to meet the terms of this agreement may entitle UNT to (1) deny my participation in the study abroad program, (2) refuse subsequent registration for any classes and/or drop current classes, (3) withhold grades, diplomas, or official transcripts from being released until the unpaid balance and other collection costs are paid in full.
- I understand that the University will place for collection any delinquent balance and that I will be responsible for all costs of collection and enforcement, including reasonable attorney's fees and court costs, in addition to other amounts due. I further understand that placement with a collection agency will make me ineligible to receive any future short-term loans from the University.
- I understand that the choice of law for the enforcement of this agreement is the statutes and laws of the State of Texas.

IT IS MY RESPONSIBILITY TO MAKE THE CONTENTS OF THIS DOCUMENT KNOWN TO THOSE WHO HAVE ANY FINANCIAL RESPONSIBILITY FOR OR ARE OTHERWISE FINANCIALLY INVOLVED IN ANY SAO PROGRAM PAYMENTS (E.G. PARENTS, RELATIVES, FINANCIAL INSTITUTIONS). I ACKNOWLEDGE THAT I AM SUBJECT TO THE TERMS OUTLINED ABOVE.
